A WORD FROM

OUR EXECUTIVE DIRECTOR:

Our fiscal year 2022 – 2023 started as we faced the reality of a post-Roe landscape along side the entire nation.

Though many Texans had been living a post Roe reality because of Senate Bill 8, the rest of the nation had to grapple with what it would now look like for abortion to be inaccessible for a large majority of people across the country. We were devastated to have to pause our Helpline services alongside other Texas abortion funds while we pursued legal action to continue supporting Texans in accessing out of state abortion care. To prepare for this moment we supported other abortion funds and clinics in receiving states for the onslaught of Texans that would continue to flood other states to receive health care that they deserve in their home state.

But everything wasn't all doom and gloom. We also had some municipal wins locally. TEA Fund has been at the forefront in Denton and Dallas, working with community partners to gain protections locally. Both city councils voted for policies that seek to deprioritize criminal investigations of pregnancy outcomes including abortion. We're harnessing our strength and leveraging our community support to do what we can to protect Texans who need abortions and their ability to get care.

We also had to strike back against harmful and racist abortion bans legally. We joined eight other Texas abortion funds and one abortion provider to stop Texas' cruel and unjust abortion laws. The uncertainty created by the Dobbs decision left us at risk of criminal liability for helping Texans access abortion care, even if that care is in another state. Our lawsuit seeks to win back our right to fund people's abortions and to protect the right of Texans to travel freely to other states.

With abortion now being illegal in Texas, we wondered why there are still anti-abortion centers (also known as crisis pregnancy centers) that the state of Texas continues to fund to the tune of \$200 million a year. We realized there is a need to combat these harmful anti-abortion centers and created the "My Choice, Not A Crisis Campaign", our initiative intent on educating communities and dismantling AACs. This campaign also provides concrete resources to parents in need—with no strings attached, builds support through community education and advocacy work, and uplifts the experiences of those who have been harmed by anti-abortion centers. Our first successful Infant Care Resource Drive on Texas Christian University campus in April 2023 was our flagship event in this new campaign. In partnership with TCU's Department of Women & Gender Studies and Dr. Nino Testa, we were able to help over 50 families with formula, diapers, wipes, medication, clothing, books, and other necessities. We hope to continue the success of the ICRD every quarter.

We also saw some tremendous growth during this fiscal year and expanded our staff to better meet the growing needs of our community. Maleeha, TEA Fund's former organizer, was promoted to Deputy Director. We onboarded a new organizer and also further expanded our programming staff, hiring a new position, our Programs Coordinator, to support our expanding programming needs. We also hired for another new position, our Communications

and Development Coordinator to facilitate and streamline operations between the Communications and Development staff. We are very proud of our new TEAm members and look forward to a long working relationship with them, as they are critical support for our growing organization.

I am very proud of the work that TEA Fund has continued to do in the face of such extreme aggression towards reproductive health, justice and freedom in Texas. I am so proud of our ability to pivot and react to critical situations when some would give up. I am most proud of our ability to support one another through the hardest of times and seeing how that supports us in showing up for our community. When adversity knocks on our door, we answer with a direct and decisive call to action that serves more people in our communities in new and inventive ways.

ADVOCACY

Rosie's Law

During the 2023 legislative session, we were able to hold our Rosie's Law Bill filing press conference with some of our most passionate supporters of Rosie's Law, Senator Sarah Eckhardt and Representative Sheryl Cole.

They co-sponsored Rosie's Law as House Bill 3586 and Senate Bill 1623. We expanded Rosie's Law so that all Texans with Medicaid or private insurance can use their insurance to pay for abortion care and the full range of contraceptive care without barriers like cost-sharing or prior authorization. Rosie's Law requires Medicaid and private insurance coverage of abortion as well as coverage for all forms of birth control approved by the FDA without cost-sharing or utilization control barriers.

Texas Abortion Funds Advocacy Day 2023

On April 25th, 2023, TEA Fund joined fellow Texas abortion funds to host an Abortion Funds Advocacy Day at the Texas State Capitol.

This event brought together passionate advocates, lawmakers, and community members to have important conversations about abortion access and anti abortion centers. Attendees engaged in meaningful conversations with legislators, sharing personal stories, highlighting the importance of policy change, and advocating for Rosie's Law in Texas. Texas abortion funds brought around 50 advocates together, meeting and planning, and had 34 elected officials regarding Rosie's Law and the harms of anti abortion centers.



Social Work Advocacy

Our Executive Director spoke to over 700 social work students from all over the state of Texas during Social Work Advocacy Day sharing information about abortion access in Texas and doing the very necessary advocacy work needed to support Texas communities.



Let's Talk About Sex Conference

LTAS is an annual conference hosted by Sister Song WOC since 2007.

LTAS is a space to boldly spotlight the connections between sex , sexuality, reproductive health, rights and justice. In the spring of 2023. LTAS was hosted in our home city of Dallas in 2023, where our TEAM was able to connect with repro advocates from across the U.S.



Texas Abortion Funds in Court

TEA Fund and other abortion funds engaged in legal action to clarify the status of so-called "zombie laws" in Texas.

These are pre-Roe laws that were nullified by Roe v. Wade. Anti-abortion extremists are trying to leverage them to harass abortion funds and isolate people who need abortions. Extremists were working overtime to try to use Texas' unjust abortion laws to stop our work and make things even harder for people seeking abortion care. We took them to court to fight for our right to help people seeking abortions. A ruling by Judge Pitman granted us this right, and we were able to reopen our Helpline in April of 2023 and begin supporting abortion seekers with out of state abortion care again.



Advocating for the GRACE Act to pass in Dallas

TEA Fund urged the Dallas city council to pass a resolution that limits the use of city resources to investigate or prosecute abortion or pregnancy outcomes that could possibly violate the Texas abortion ban.

TEAFund PROGRAMS

Infant Care Resource Drive

We had our first Infant Care Resource Drive in April with our amazing partner professor Nino Testa and the Women's and Gender Studies program at TCU in Fort Worth.

We helped 50 families and learned what the needs in the community are, we shared stories about anti-abortion centers, and the harms they are still causing to so many pregnant Texans. We aim for the ICRD's to become quarterly events.

We held a fundraising event to raise funds for our Infant Care Resource Drive and it was very successful and popular in the community.





PROGRAMS

Helpline

Our Helpline was shut down after the Dobbs decision in June 2022, and we did not reopen it until 2023. We had so many legal issues to sort through, and we were unsure if funding abortions out-of-state would put us in legal limbo. However, we did send some money to abortion funds in receiving states that we knew our callers would be the most likely to go to give them more capacity to help the new influx of Texans overwhelming their healthcare systems.

Text Line

TEA Fund’s text line was also shut down until end of March 2023.

Path

We were able to ramp up our PATH program and grow our membership at this time. Our PATH group has expanded by 307%.

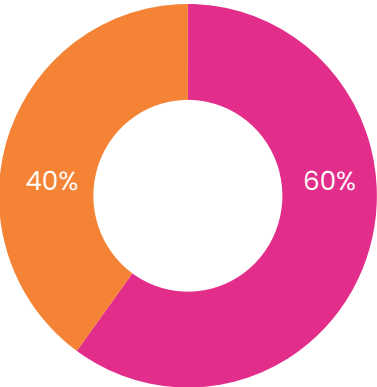

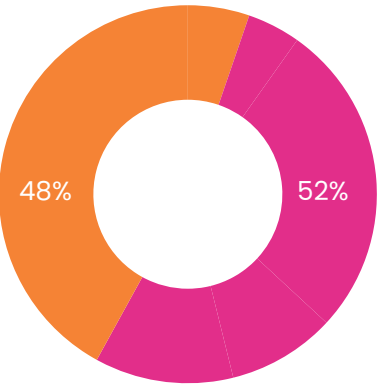


TEA Fund Parenting Data

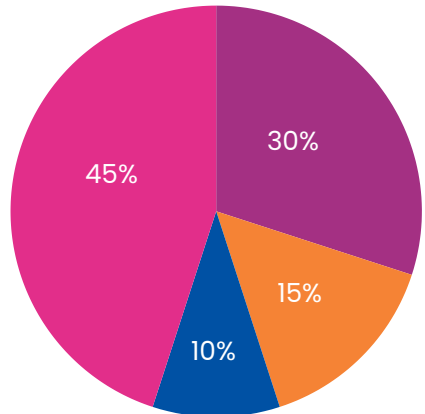

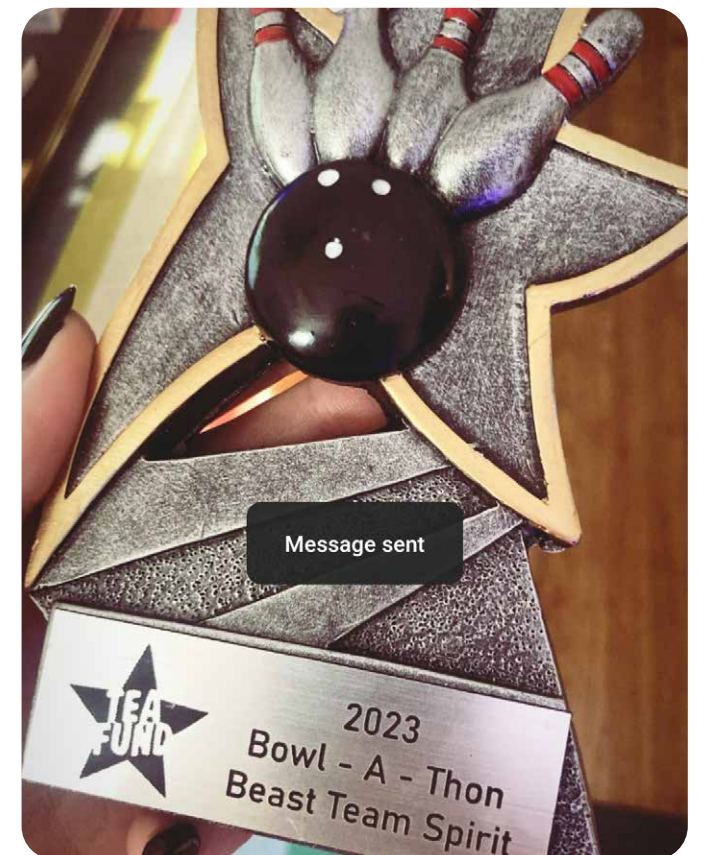
Bowl-A-Thon

FEDERAL RULING PROTECTS TEXAS ABORTION FUNDS' ABILITY TO PAY FOR OUT-OF-STATE ABORTIONS AND TRAVEL

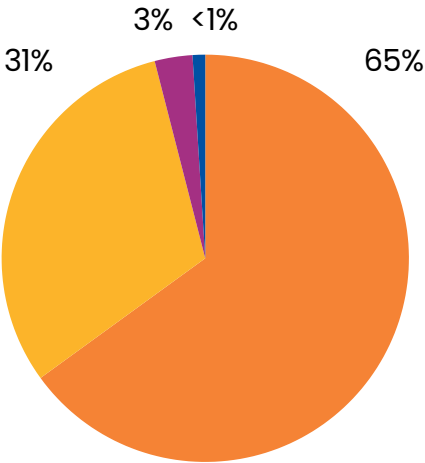

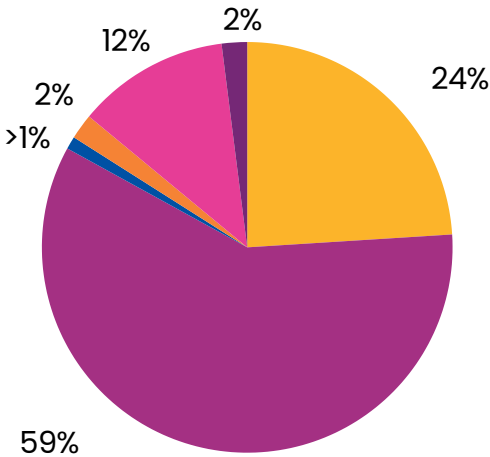

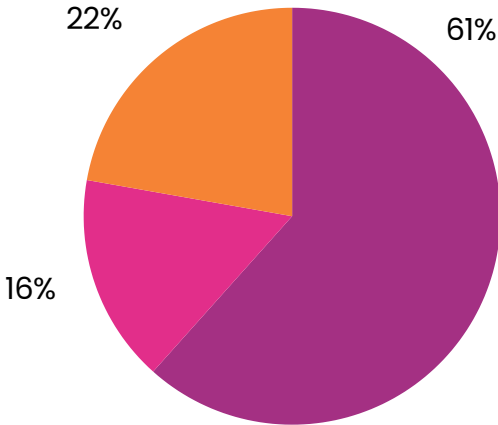
